IN ORDER TO TAKE A DRIVING SAFETY COURSE IN LIEU OF A CONVICTION BEING ENTERED ON MY DRIVING RECORD, I HEREBY STATE UNDER OATH:

- I HAVE REQUESTED THE DRIVING SAFETY COURSE ON OR BEFORE MY ANSWER DATE.
- I HOLD A VALID TEXAS DRIVERS LICENSE. (CDL NOT ELIGIBLE.)
- I HAVE NOT HAD A DRIVING SAFETY COURSE IN THE LAST YEAR AND AM NOT PRESENTLY ENROLLED IN A DRIVING SAFETY CLASS AT THIS TIME.
